**Prior Meeting Minutes:** The June 5, 2018, minutes were emailed and distributed before the meeting. They were accepted as presented on a motion by Andy and Denis.

Treasurer's Report: Terry reported:

**New Business:** 60 letters to the MH Open competitors went out recently, but Steve suggested we ensure we get readable email addresses on the applications to send these next year. We will hand out jobs at the next meeting. We again will try to ensure no one brings fish up to weigh before being called.

We discussed how to count the fish in pre June 15 tournaments. A hybrid paper (12-15") and weighed (15+" weigh in, and changing the site to DE or VA, which lack the MD limit, were suggested to handle this problem. We also mentioned dropping a bad or missed tournament in the points hunt. There also was support for changing how tournaments are picked. These and other suggestions can be considered over the winter.
