Treasurer's Report: Terry did not report the data below at Lake Anna. Last month report balance: \$649.35 (10/28/2016) + \$21 cash = \$670.35

Bylaws changes: Nothing was offered. They stand as published.

**New Business**: Jim needs a time and date for the banquet, so we decided to have it March 4 at the Sunset Room, the same as last year, with March 11 as the alternative. Consensus was we do a cash bar, that is, pay as you order from the bar, to avoid being short on the bar tab like last year.

**Tournaments**: Your preferences on sites for 2017 tournaments were:

10 tournaments, maybe 11, starting April and ending in November. Preferred sites: Lake Anna 2-day, Black Hills, Potomac twice, Susquehanna Flats, Conowingo, Trap pond, Marshyhope, Nanticoke, Lake Anna and Wicomico. Andy will work out dates and we will finalize the schedule in January. Denis suggested we schedule another November date as an alternate, if we have to cancel one. Agreed. Most, if not all, preferred fishing shorter times and starting earlier, if heat is an issue. Andy offered to schedule an alternate site to fish, if Conowingo is too windy to be safe. We all agreed that the tournament director, president and president of vice will decide weather related issues for us, preferably 2-3 days prior, based on weather reports. (The Bylaws state that the Safety Officer "is responsible for caucusing with the President and Tournament Director regarding decisions to cancel, postpone or "early call" tournaments due to inclement weather or other safety matters." So the VP is off the hook.)
