Treasurer's Report:

Expenses: Awards \$261, Hella's \$642.46, and Web host \$119.40 (M&T \$10, S.R.dues \$25)

Last month report balance \$1,398.82 (2/27/2015)

Month statement balance: \$138.56 (4/6/2015) - \$10 M&T Fee

Current available balance: \$128.56 + \$36 cash = \$164.56

Steve will contact M&T about the monthly fee, which is excessive for our average balance.
